3. Further, as per RFP documents, the contractor for due and faithful performance of its obligations during the Construction period as well as Defects Liability Period, shall furnish a "Performance Security" amounting to Rs. 10,50,00,000/- (Rupees ten crore fifty lakh only) and an additional performance security of Rs. 12,73,00,000/- (Rupees twelve crore and seventy three lakhs only) by way of an irrevocable and unconditional Bank Guarantee in accordance with Clause 7.1.1 of Article 7, Vol.-II of RFP documents and Clause 2.21.1 of the RFP document. The Performance Security shall be valid until 60 (sixty) days after the Defect Liability Period.

4. You are required to comply with all terms and conditions set forth in the RFP documents. In case of any default on your part, you shall be liable for action as stated in the RFP documents.
