In accordance with the Regulation 30 of the Securities and Exchange Board of India (Listing Obligation and Disclosure Requirements) Regulation 2015, we are pleased to inform you that we have received a work order of Rs. 20,25,18,264.00 (Rupees Twenty Crores Twenty Five Lakhs Eighteen Thousand Two Hundred Sixty Four Only) from M/s SCPL-ARSS (JV) for execution of following works in relation to Koraput-Singapur Road Doubling Project:

- 1. Providing, cutting, fabricating, treating, fixing & painting structural steel conforming to IS:2062 in access ladders, inspection platforms, Trolley refugee, railing, etc. joints welded to neat finish including one coat of primer & two coats of synthetic enamel paints
- 2. Supplying, fitting and fixing in position true to line and level cast steel rocker bearing complete as per IS: 7666, IS:9565, IS:1030, IS:919, IS:3073 and as per Bridge Code including all accessories as per drawing and Technical Specifications
- 3. Supplying, fitting and fixing in position true to line and level forged steel roller bearing conforming complete as per IS: 7666, IS:9565, IS:1030, IS:919, IS:3073 and as per bridge code including all accessories as per drawing and Technical Specifications
- 4. Design, Supplying, fitting and fixing in position true to line and level elastomeric bearing conforming to IS:3400, IS:226, BS 5400 complete including all accessories as per drawing and Technical Specifications
- 5. Fabrication, supply, assembling, riveting, welding, bolting where ever required with contractor's rivet material, weld materials, bolts, HSFG Bolts, Stud shear connectors, service bolts erection and launching of ,45.40 m span, 30.50 m span,24.40 m Span,18.3m span and 12.2m span welded Composite girders as per Railway approved drawings referred at General Note Sl. No.5 above with contractors Structural steel confirming to IS

2062. All structural steel shall conform to Quality "B0" Grade Designation E250 specification (Plates less than 12mm thick need not be with normalizing/normalizing rolling/controlled rolling) and rivets, nuts and bolts, Stud shear connectors, HSFG bolts, welding etc. including contractor's own material, fabrication machinery, templates, fixtures, equipments, tools and plants approved quality paint, transportation skilled/unskilled labors, excise duty, octroi, sales tax, and other taxes, all lead, lift etc complete. The rates are inclusive of trail assembly, transportation of fabricated girder parts to site by contractor's own means at his own cost. The rate shall also be inclusive of cold straightening of deformed and bent girder parts before their assembling and other ancillary steel structures where ever necessary for proper level and alignment. The rate shall be inclusive of supply, erection and dismantling of staging and scaffolding and other temporary arrangements wherever required for the purpose of assembly, erection and launching of girders. The launching has to be done as per scheme supplied by the contractor and approved by Railway with the help of contractor's road cranes of suitable capacity /launching nose etc. as approved by Railway. The contractor has to bring all the bridge girder components after doing Metallization, priming coat i.e. one coat of etch primer (as per IS: 5666) one coat of Zinc Chrome primer (as per IS: 104) to the site. After transportation, assembling and erection at site, two coats of finishing coat with aluminum paint as per IS: IS:2339 to be applied after touching up the priming coat if damaged in transit.(Metallization will be paid under Item No.2 of this Schedule) Note: Top plate, bottom plate, stopper strips of Elastomeric bearings will be paid under this item. Note:ii)50% of the accepted rate will be paid against equivalent amount of bank guarantee, on supply of steel for fabrication at the approved workshop. The validity of bank Guarantee given should be at least one month beyond the date of completion of launching of the girder. The bank guarantee given will be released after successful completion of launching of girder. iii) 25% of above rate will be paid after complete fabrication carried at approved workshop in all respects including drilling holes, metallization and one coat of painting at workshop and transport the fabricated girder to the site of work. iv)15% of above rate will be released after assembling of girder at site of work to the satisfaction of Engineerincharge, submission and approval of design & drawing of launching scheme and after successful launching of girder. v)Balance 10% of the above rate will be paid after successful completion of work in all respects including painting and miscellaneous works.
